Minutes of the meeting of Londesborough Parish Council held on Monday 13 January, 2020 in the Reading Rooms, Low Street, at 7.30pm.

01/20 Cllr Stephenson, welcomed everyone to the meeting. Apologies for absence were received from Cllr I Bessey

02/20 Declaration of Interest. The Parish Councils Code of Conduct. To record any declarations of interest by any member in respect of items on this agenda. There were no declarations of interest.

03/20 To resolve that the meeting is temporarily suspended to allow for a period of **Public Participation**. There were no members of the public present.

04/20 The minutes of meeting held on 11 November 2019 were proposed by Cllr Fisher, seconded by Cllr Lambert and agreed as a true record and Cllr Stephenson signed them as such on behalf of the council.

05/20 To receive the clerk's report on matters being progressed from previous meetings.

Broadband – ERYC had given an update re Park Farm and there had been a problem with wayleaves for the work to go ahead, and some of the wayleave delays were due to Openreach making some errors on previous documentation but now corrected. In terms of the Hall, there are not currently plans for a fibre connection there, however it is likely that the Hall will be eligible for fibre provision in the next phase of the Broadband East Riding Programme build work for which is due to start in Autumn 2020 and finish in Winter 2021. Mrs Ashwin had been enquiring about broadband to the Hall and it was agreed to give a copy of the e-mail received from ERYC.

Interpretation Board – Cllr Stephenson was still awaiting quotations for the repairs, it was suggested that enquiries be made with "The Men in Sheds" to see if this was a project that they may be able to undertake.

Londesborough Roundabout – The Clerk had made an enquiry with Langlands Garden Centre with regard to sponsorship and was awaiting a reply.
