Minutes of the meeting of Londesborough Parish Council held remotely via Microsoft Teams on Monday 9 November, 2020, at 7.30pm.

Present: Cllr G Stephenson, Cllr J Fisher, Cllr K Watson, Cllr A Fisher, Cllr E Lloyd-Huitson, Cllr J Dunning, Cllr J Dickinson-Shaw, S Moore (Clerk)

43/20 Cllr Stephenson, welcomed everyone to the meeting. There were no apologies for absence.

44/20 Declaration of Interest. The Parish Councils Code of Conduct. To record any declarations of interest by any member in respect of items on this agenda. There were no declarations of interest.

45/20 To resolve that the meeting is temporarily suspended to allow for a period of Public Participation. Cllr Stephenson welcomed Trevor Hudson and Lee Rooks to the meeting and also Craig Ulliott, the Conservative Candidate for the next Police & Crime Commissioner election. Trevor and Lee had expressed an interest in joining the Council and were able to have an informal discussion with Councillors and tell them a little about themselves. Cllr Stephenson thanked Trevor and Lee for their interest and for joining the meeting. Craig Ulliott spoke about the initiatives he would introduce in the role of Police & Crime Commissioner, including introducing a rural task force, 230 more police officers being recruited in the area, he also asked about what specific problems were encountered in the rural parish including county lines and speeding/speed limits. Cllr Stephenson thanked Mr Ulliott for attending the meeting.

46/20 The minutes of meeting held on 7 September 2020 were proposed by Cllr Fisher, seconded by Cllr Dunning and agreed as a true record and Cllr Stephenson signed them as such on behalf of the council.

47/20 To consider co-option of a Councillor – The Clerk informed the Council there were two vacancies on the Parish Council which had been advertised and could now be filled by co-option. Cllr Dunning proposed, Cllr Fisher seconded and it was agreed that Trevor Hudson and Lee Rooks be co-opted and would both join the Council at the next meeting after signing a declaration of office.

48/20 To receive the clerk's report on matters being progressed from previous meetings.

Broadband – ERYC confirmed that Openreach had now completed the work at Londesborough Hall and Park Farm. The residents at Woodbrades could use the Gigabit Voucher Scheme (GBVS) to offset the cost of installing a connection.

Interpretation Board – The interpretation board had now been reinstalled and an invoice for the work had been received. After discussion it was also proposed to make an additional

donation to the “Men in Sheds” who were a voluntary group. Cllr Dunning proposed Cllr Fisher seconded and it was agreed to further donate £20 to the charity.

Defibrillator Pads – Cllr Fisher reported that two new pads had now been installed.

Dog Fouling – The Clerk had enquired about dispensers for dog fouling bags however this was not something supplied by ERYC but were available online or from pet shops. It would not however be possible to install any around the village at the present time.

Woodbrades – The road and access had been inspected by ERYC but they do not maintain residential accesses made up of loose bound material however should the resident wish to improve the access at their own expense a vehicle access pack (£41) could be applied for. Cllr Dunning to pass on this information.

Londesborough Roundabout – The Application to ERYC Community Tree Planting Fund was not successful. The possibility of neighbouring parishes contributing to the scheme was to be investigated.

Mrs Barbara Ashwin – The Clerk had sent a letter of condolence on behalf of the Parish Council to the family of Mrs Ashwin.
